A message from the President & Executive Director

The year 2014 was a challenging one for Luke's Place. We experienced our first year of significant financial set-back resulting from the reality that we have no core annualized support from government. When a major grant ended in December 2013 and no replacement funding could be secured despite our best advocacy efforts, a number of staff positions and program capacity cuts were necessary. This resulted in our first ever decrease in the number of women and children served, down a staggering 21% from 2013. It also resulted in our first ever operating deficit and use of some reserve funds to cover expenses. Our remaining staff of 5, most working part-time, went above and beyond to still serve 528 women in Durham Region last year. The number of women who seek our services to help free themselves and their children from abuse continues to grow annually. We simply don't have the funding necessary to reach service capacity and we risk incurring longer and potentially life threatening wait times. It is alarming knowing the effect this has on the safety and well-being of women and children not just in Durham Region but across the province.

The outstanding leadership we pride ourselves in offering – through our unique service delivery model, tools and resources for frontline workers and women as well as training and support we offer to hundreds of legal advocates across Ontario – makes Luke's Place a true Centre of Excellence for Family Law and Violence against Women. We are confident that 15 years of ground-breaking achievements will enable us to secure the sustainable funding we need to continue to move this important work forward.

Late in 2014, Luke's Place did experience success with new project funding and some exciting new initiatives are getting underway. We remain committed to pursuing more stable support for our critical work and we invite you to help us achieve this.

About Luke's Place

Luke's Place **mission** is to support abused women and their children throughout the family law process and to provide them and their communities with specialized resources about family law and woman abuse. Our **vision** is a family law system that promotes healthy, safe families.

Luke's Place is devoted solely to improving the safety and experience of abused women and their children as they proceed through the family law process. We have focused on the development of a specialized response to support abused women in this difficult and challenging process, development and continuing updates of resources, tools and training processes for advocates and the provision of community based training and mentorship for service providers. Luke's Place has also focused on raising the profile and understanding of these issues provincially and internationally through leadership or participation in think tanks, stakeholder consultations, and conferences and completion of academic and community based research. Input and feedback is provided on the work of Luke's Place by the Women's Advisory Group, comprised of woman abuse survivors and the Legal Advisory Group which provides consultation about the legal dimension of our work.

Luke's Place is named after a 3½ year old boy killed by his father in 1997. Luke's mother, Kate, had serious concerns about Luke's safety with his father and had applied for supervised access through the family court process. She was unsuccessful and Luke was killed by his father, who then killed himself, on their first unsupervised access visit. Following Luke's death, the community came together to work to make sure no other child would face a similar fate. Kate played an important role in the work done in Durham Region, as did many other women who had left abusive relationships. One of the products of that work was Luke's Place - Canada's first stand-alone family law resource and support centre for abused women and their children.



Current programs & services

Luke's Place works to improve the safety and experience of abused women who are or who may become involved with the family law system. We offer women and their children in the Durham Region free:

- > confidential family law support services in Oshawa and Ajax locations and onsite at family court at Durham Region Courthouse
- individual consultations with Legal Support Workers
- > summary advice from family law lawyers and assistance with court documents at our Legal Clinic
- group support sessions and legal information workshops
- accompaniment to legal and court appointments and meetings to debrief outcomes
- provide family law support referrals for men who have experienced abuse

In the Durham community and across Ontario we:

- offer training and resources for service providers in person and at <u>www.lukesplacetraining.ca</u> on a fee for service basis
- > lead the Family Court Support Worker provincial training initiative funded by Ministry of the Attorney General
- > engage in academic and community based research and consultation
- > provide community education, specialized resources and online reference manuals

Statistics

Luke's Place experienced an unavoidable direct service staff reduction in 2014 when a major grant ended. This caused our direct service numbers to decline 21% from 2013 to 528 women (400 of whom were new to our services) to whom we provided support with family law issues through in-person, telephone and electronic consultations, court accompaniment, groups and workshops. Luke's Place also provided education, training and resources to more than 500 service providers across the province.

This intense level of service is not sustainable with reduced staff and would soon result in increased wait times during a potentially dangerous time for abused women and their children.



New in 2014

The "After She Leaves" training project wrapped up this year and was a resounding success. A total of 306 service providers were trained over 2 years and 103 women in Durham Region attended legal information workshops. Training for service providers supporting abused women through the family law process was delivered in Durham, Hamilton, Peterborough, North Bay, Ottawa, Thunder Bay, Sault Ste Marie, Toronto, Barrie and London with support from Status of Women Canada. Access to extensive online resources including the "After She Leaves" manual was provided in a private area on the Luke's Place training website.

With pilot project funding from Legal Aid Ontario, Luke's Place is working in partnership with the new Durham Family Law Service Centre to provide a safe, supportive site for abused women to receive summary legal and support services. Building on its successful pro bono clinic model of a lawyer/legal support worker team approach, Luke's Place will increase and enhance legal services to lower income, vulnerable women. This project will close the gap between the current financial eligibility for legal aid and the federal government's Low Income Measurement. It will offer women who've experienced abuse and who would not normally qualify for legal aid with the opportunity to receive legal services including summary legal advice, document preparation and some court representation. Our strong collaborations with violence against women and social service agencies in Durham will ensure a holistic, wrap around service addressing intersecting needs of clients. This funding provides a unique opportunity to enhance and test a model which could ultimately be applied across the province.

In a separate contract with Legal Aid Ontario Luke's Place has designed and is delivering domestic violence awareness training for all Legal Aid Ontario employees over the next year.

With funding from the Law Foundation of Ontario, Luke's Place completed an inventory and mapping of the violence against women family law support work currently being done in Ontario. This inventory focuses on organizations engaged in the following activities:

- Providing frontline support to women who have experienced abuse and who are involved in the family law/court process, including shelters, community counselling agencies, settlement and other immigrant service agencies, agencies providing Family Court Support services, sexual assault centres, victim services, etc
- > Providing training and education about family law and violence against women to the violence against women sector, court personnel, lawyers, judges and others
- Engaging in law and process reform advocacy

Where do we go from here?

Financial support in 2013 from Green Shield Canada, Baagwating Community Association, McLean Foundation and George Lunan Foundation began the documentation of Luke's Place service delivery model into a toolkit. We are seeking funding so Luke's Place can complete and share this user friendly toolkit online with agencies in North Eastern Ontario who would benefit from enhancing their family law support programs for abused women in their own communities. Luke's Place hopes to work closely with a number of organizations in the North East between Parry Sound and Moosenee to provide training and online support in their adaptation of elements of our model, as well as to enhance their work with family law lawyers. In partnership with the Barbra Schlifer Clinic, we are seeking funding to develop an online course and best practice guidelines for lawyers to support these organizations in the provision of virtual pro bono summary legal advice services for abused women. The resources and processes developed in this project will build an infrastructure that can ultimately be accessed by service providers throughout Ontario.

Fund development & marketing

An Ontario Trillium Foundation 2 year grant provided funding for a part-time Fund Development & Marketing Manager which ended January 2014. The project resulted in the rebranding of Luke's Place logo and marketing materials as well as the development of a fundraising campaign "Make change. For change". The primary objective of this ongoing campaign is to increase donations to Luke's Place by encouraging local businesses, individuals, groups and corporations to make a positive change within their networks to raise money and awareness for Luke's Place.
