#### One woman speaking out about change\*

Before coming to Luke's Place I was scared and didn't know where to turn for help. I had been in a financially and emotionally abusive relationship for over 20 years, I knew I wanted it to end but my abuser told me he wasn't cooperating and I had better get used to the status quo.

I had no viable source of income for supporting myself and my two children. I was so desperate I had worked out a budget for the only escape plan I thought I could afford-a sub temperature sleeping bag and a no frills membership to the local gym that would allow me to live out of my car and clean myself up at the gym. Thankfully, Luke's Place was there to show me that I had other alternatives.

The legal system can be scary and my abuser tried to use scare tactics to get me to stop the divorce process but thanks to the education Luke's Place provided I was able to tell the difference between fact and fiction/scare tactics and reality.

The assets I had on paper (but couldn't get from my abuser) didn't qualify me for Legal Aid and that was scary but Luke's Place again showed me that I had options.

Luke's Place helped me stay strong and determined throughout the process. They educated me on the process which helped relieve a lot of my fears but they also provided liaisons to a network of support services. I knew I was not alone and I had lots of support in my community. They also taught me how to keep me and my children safe throughout the process; the techniques they taught me I am convinced helped contain several potentially volatile situations.

Today, my process is not yet over but I am now able to navigate the system with the help of my lawyer and Luke's Place continues to help keep my costs down by continuing to provide legal support when needed. I have a new home with my two children, I am confident in my ability to persevere and I am no longer afraid. I am free of my abuser and I no longer see his premonitions of misfortunes for me as a threat.

I will forever keep in my heart the tremendous support I received from Luke's Place; my children and I would not be free today without their help.

#### About Luke's Place

Luke's Place is named after a 3½ year old boy killed by his father in 1997. Luke's mother, Kate, had serious concerns about Luke's safety with his father and had applied for supervised access through the family court process. She was unsuccessful and Luke was killed by his father, who then killed himself, on his first visit. Following Luke's death, the community came together to work to make sure no other child would face a similar fate. Kate played an important role in the work done in Durham Region, as did many other women who had left abusive relationships. One of the products of that work was Luke's Place - Canada's first standalone family law resource and support centre for abused women and their children. Luke's Place is devoted solely to improving the safety and experience of abused women and their children as they proceed through the family law process. We have focused on the development of a specialized response to support abused women in this difficult and challenging process, development and continuing updates of resources, tools and training processes for advocates, and the provision of community based training and mentorship for service providers. Luke's Place has also focused on raising the profile and understanding of these issues provincially and internationally through leadership or participation in think tanks, stakeholder consultations, and conferences, and completion of academic and community based research. Input and feedback is provided on the work of Luke's Place by the Women's Advisory Group, comprised of woman abuse survivors and the Legal Advisory Group which provides consultation about the legal dimension of our work.

Luke's Place mission is to support abused women and their children throughout the family law process and to provide them and their communities with specialized resources about family law and woman abuse. Our vision is a family law system that promotes healthy, safe families.



#### Current programs & services

Luke's Place works to improve the safety and experience of abused women who are or who may become involved with the family law system. We offer:

- free family law support in confidential Oshawa and Ajax locations
- services on site at family court, Durham Courthouse
- individual consultations with Legal Support Workers
- summary advice from family law lawyers at our Pro Bono Clinic
- group support sessions and legal information workshops
- accompaniment to legal and court appointments
- training and resources for service providers across the province
- lead for the Family Court Support Worker provincial training initiative funded by Ministry of the Attorney General
- research and consultation
- sommunity education
- resource library and online reference manuals
- family law support referrals for men who have experienced abuse

#### **Statistics**

In 2013 Luke's Place provided direct service to 672 women (442 of whom were new to our services) with family law issues through in-person, telephone and electronic consultations, court accompaniment, groups and workshops. This represents a 15% increase in the number of women served over last year. Luke's Place also provided education, training and resources to more than 400 service providers across the province.



#### New in 2013

The 2013 Family Court Support Worker (FCSW) 2-day Annual Gathering held in Toronto, was attended by 56 FCSW's from across Ontario. Workshops were presented by Deborah Sinclair, Shannon Moroney, Rhonda Roffey and Pamela Cross. Panels included: FCSW's sharing expertise from across the province; Legal Aid Ontario; and Office of the Children's Lawyer.

After She Leaves trainings were delivered in Hamilton, Peterborough, North Bay, Ottawa and Thunder Bay, with support from Status of Women Canada, to 143 service providers supporting abused women through the family law process. Access to extensive online resources including the After She Leaves manual were provided in a private area on the Luke's Place website.

With financial support from Green Shield Canada, Baagwating Community Association, McLean Foundation and George Lunan Foundation Luke's Place acquired and customized a case management database, was able to offer enhanced services to 15% more women this year and work began on the documentation of Luke's Place service delivery model toolkit. With additional financial support, this user friendly toolkit will be completed and available online to agencies across Ontario who wish to enhance their family law support programming for abused women.

#### Fund development & marketing

An Ontario Trillium Foundation grant provided funding for the second and final year of a part-time Fund Development & Marketing Manager. The inaugural project in year one was the professional development of a consistent new look and voice for Luke's Place which was followed by the modification of all communications materials. These materials continue to be disseminated through a variety of channels to our clients, partners, funders and community members. Further to these efforts, we re-branded and enhanced



www.lukesplace.ca using a separate revenue stream.

Luke's Place has continued to promote and expand our 'Make change. For change. Community Fundraising Challenge' that launched in December 2012 with \$150,000 worth of unpaid advertising support through Pickering Town Centre's Ladies Room. The primary objective of the campaign is to increase donations to Luke's Place by encouraging local businesses, individuals, groups and corporations to make a positive change within their networks that will raise money and awareness for Luke's Place. In tandem with the campaign, small grant requests were continuously made with heartfelt thanks to the private foundations who have shown their support.

A communications strategy was developed that included joining 3 Chambers of Commerce in Durham Region to leverage their membership bases for fundraising campaign promotion. A retractable banner was created and incorporated into a mobile display for use at Chamber events and the campaign flyer was circulated to 7,300 unique Durham Region businesses. The flyer was also used as the creative inspiration for a compelling campaign video and <a href="https://www.makechange.ca">www.makechange.ca</a> website where the video can be viewed. Our social media marketing on facebook, twitter and LinkedIn continues to grow.







There was significant local media publicity for Luke's Place this year with several photos in Snap'd Newspaper at events and cheque presentations and regular presence on durhamregion.com. Additionally, Metroland Durham Region Media Group featured a full page editorial with delivery to almost 200,000 homes and Rogers TV provided two 5 minute interviews on Daytime.
